Purpose

Catalyst is the Australian Government's new funding program for the arts. It will invest \$12 million each year in innovative projects and initiatives from arts and cultural organisations.

Overview

Catalyst will assist organisations to forge new creative and financial partnerships and stimulate innovative ways to build participation by Australians in our cultural life. It will prioritise access to high quality arts experiences in regional communities and international activities that achieve cultural diplomacy objectives.

Projects by, or that involve, small to medium organisations will be given priority. The fund may also support some gallery, library, archive, museum, arts education and infrastructure projects.

Funding will be available through annual or multi-year Funding Agreements up to a maximum of four years, subject to availability of funds.

Ordinarily, individual projects will not receive more than \$500,000 in one year. Applicants should keep in mind that Catalyst seeks to support a diverse range of quality projects in each of the Catalyst streams. To remain competitive, all applications for funding should include realistic budgets and achievable timeframes, and an explanation of the expected impact and public benefit of the project.

Objectives

Catalyst will:

- deliver a diverse range of quality arts and cultural experiences that grow participation throughout Australia and internationally
- strengthen Australia's reputation as a sophisticated and artistic nation with a confident, outward-focused arts sector
- increase partnerships with the private and philanthropic sector to increase project investment
- support collaborations to develop arts and cultural projects including in specific regions or priority areas
- give priority to projects involving small to medium organisations

What Catalyst will fund

Catalyst will fund high quality projects irrespective of scale in all art forms, including screen-based art work and cross art form projects, including but not limited to:

- Performances
- Exhibitions
- Tours
- Development and/or creation of new work
- Festivals
- Investment in foundation fellowship programs (Partnerships and Collaborations stream only)
- Capacity building
- Infrastructure projects (Partnerships and Collaborations stream only)
- Artistic cultural exchanges

Limitations

To be eligible for funding, applicants must:

- be an Australian incorporated organisation or entity
- have as their principal purpose the arts and/or cultural heritage
- have an active Australian Business Number (ABN). Organisations incorporated under Norfolk Island law are eligible for funding
- be registered for the Goods and Services Tax (GST), if required by the Australian Taxation Office
- not have any outstanding reports, acquittals or serious breaches relating to any Commonwealth funding

Unincorporated groups with primarily an arts or cultural heritage purpose are eligible for funding but must be auspiced by an organisation that meets the above criteria.

Individual business units and entities of local government authorities with an arts or cultural heritage purpose (such as art galleries or performing arts centres) are eligible to submit applications.

What Catalyst will not fund?

- Individuals
- Competitions
- Awards
- Business start-up costs
- Private tuition, training or study
- Work used for academic assessment
- Eisteddfods
- Film and television production
- Operational funding for organisations (note this differs from administrative costs associated with undertaking funded projects)
- Interactive games
- Built or natural heritage projects
- Components of projects that are also funded by other programs administered by the Ministry for the Arts, the Australia Council or Creative Partnerships Australia
- Costs associated with a project that have already been incurred

Purpose

The Contemporary Music Touring Program (CMTP) supports national touring activity undertaken by Australian musicians performing original contemporary music. It provides travel support of up to \$15,000 for artists and their manager for tours in Australia that include performances in regional and remote areas.

Overview

Under the CMTP performances of original Australian contemporary music can include a wide range of different musical styles.

Applications must contain one tour only. The tour must comprise of performances in at least three venues outside of the performer's hometown and must include at least one performance in a non-metropolitan area. Tours that include a majority of regional destinations or assist performers from regional areas are a priority for funding.

Additional TRAX funding is available for tours where over 75% of the itinerary is to remote and/or very remote locations. The Accessibility/Remoteness Index of Australia (ARIA) helps determine the regional and remote reach of the tour. To find out if you meet the ARIA rating to qualify for TRAX funding, begin a grant in the Australia Council's online system.

Joint tours, where two or more independent performers are undertaking the same tour itinerary, are eligible under this program. These should be submitted as a single application. In such cases, the funding cap of \$15,000 still applies (unless the tour is eligible for additional TRAX funding).

We encourage the inclusion of additional activities which extend opportunities for community participation, such as workshops, master classes and all-age performances.

Limitations

Who can apply

Funding on a tour by tour basis is available to enable professional musicians to tour live music performances within Australia. Touring musicians must be performing original Australian contemporary music. Funding can be provided to performers, managers, agents, and music networks on behalf of professionals working in the Australian music industry.

Who can't apply

You can't apply for a grant if:

- you received a grant, or administered a grant, from the Australia Council in the past and that grant has not been satisfactorily acquitted
- you owe money to the Australia Council.

You can't apply for the following activity:

- a tour to less than three venues
- tours to metropolitan venues only
- overseas tours or overseas performers

- tours which are primarily school-based (except for applications seeking TRAX funds where the school is the primary venue of a remote or very remote location)
- a series of performances at one festival
- competitions, such as 'Battle of the Bands' events
- attendance at conferences

Limitations

Applications are only accepted from organisations that have Deductible Gift Recipient status.

Individuals wishing to apply for funding for projects are advised to partner with a Public Institution which then takes responsibility for the project.

The Trustees will normally consider only one application per organisation in any given year.

Purpose

Through our Arts program area we aim to help build the calibre and capacity of Australia's arts organisations and support them to raise the bar of aspiration and achievement in the sector. We seek to foster appreciation of the arts and to develop opportunities for greater access to the arts, particularly in rural and regional areas.

Overview

The Foundation seeks to support Australian cultural institutions and organisations which are distinctive in artistic achievement, imagination and innovation, and programs that work strategically to help such organisations reach their goals. At a local level, the Foundation seeks to extend cultural opportunities to regional centres and encourage the development of arts programs throughout Australia's varied and vibrant communities.

Objectives

- To support cultural institutions and organisations in Australia which are distinctive in artistic achievement, imagination and innovation.
- To extend cultural opportunities to regional centres, and encourage the development of arts programs at a local level.

Applicants are required to speak with a Program Manager if submitting an Expression of Interest (EOI) for a grant of more than \$100,000.

The Ian Potter Foundation rarely awards the full amount of any project. Please ensure that you have alternative providers of funding, and that your application clearly considers any possible grant from the Foundation in this context. We very rarely fund 100% of a project cost.

Purpose

The PPCA Performers' Trust Foundation was established in June 1975, for the purpose of promoting and encouraging music and the performing arts. To do so, the trustees – four representatives from the music industry – assess applications and provide grants to selected beneficiaries.

Overview

All applications for grants are reviewed by the trustees and must be for one or more of the following purposes:

- performances at concerts at or for charitable institutions such as hospitals or homes for the aged
- scholarships for the promotion and encouragement of musical and theatrical education
- the promotion and encouragement of the performing arts to the general public
- the aid or assistance of any beneficiary who is unable to adequately maintain herself/himself by her/his own exertions and other income.

A grant under the PPCA Performers' Trust Foundation can be used for costs associated with the above, including:

- Tuition fees
- Travel costs (hire, airfares, petrol)
- Accommodation
- Venue hire/ PA hire.

A grant cannot be used to cover wages, salaries, commissions etc.

The trustees meet four times a year to consider applications. Applications are circulated to all trustees prior to each meeting.

There is no specified limit. However, funds are finite and there is no guarantee that you will receive all or any of the funds you request.

It is unusual for grants to be approved in excess of :

- \$3,000 for an individual; or
- \$5,000 for a group or organisation

Limitations

A grant cannot be used to cover wages, salaries, commissions etc.

Although the trust is discretionary, the trustees are guided by the 'purposes' articulated in the trust deed. As a result, it is not their usual practice to approve funding for any project of a commercial nature. This would include:

- investments in recordings (e.g., studio time, producers fees, session musician fees, manufacturing or distribution costs);
- concert or festival promotion or staging costs;

- tour support;
- artist management expenses; or
- equipment purchases.

You should also note that the trustees are unlikely to approve applications seeking funding for the majority of costs related to a project, and look to applicants to contribute and/or explore additional funding sources.

NEIS is a programme delivered by a network of 21 providers who provide individualised help for job seekers to become self-employed business owners.

Overview

If you want to start and run a new small business, you may be eligible to participate in NEIS, delivered as part of jobactive.

A total of 6,300 places in NEIS are available nationally each year, delivered by a network of NEIS providers.

NEIS can help you become a self-employed business owner. NEIS providers offer support to turn a good idea into a viable business through:

- accredited small business training
- income support (the NEIS Allowance—up to 39 weeks) and rental assistance (up to 26 weeks)
- business mentoring from a NEIS provider in your new business' first year.

Limitations

Who is eligible for NEIS

You can participate in NEIS if you:

- are fully eligible for jobactive or are a Disability Employment Services participant in the Employment Assistance Phase
- are participating in jobactive as a Volunteer and commence in NEIS Assistance before the end of their period of service.

You must also:

- be at least 18 years of age at the time you start NEIS
- be receiving an eligible income support payment such as Newstart Allowance, Parenting Payment, Carer Payment, Disability Support Pension or Youth Allowance (Other)
- not convert to the Age Pension before or during participation in NEIS
- be available to participate in NEIS training (if relevant) and work full time in the proposed NEIS business
- not be an undischarged bankrupt
- not have, at any time, received NEIS Assistance for a similar business activity
- not have received NEIS Assistance in the previous three years.

If you are a recipient of Disability Support Pension, Carers Payment, Parenting Payment (Single) and some Department of Veterans' Affairs pensions, you can choose to remain on these payments while participating in NEIS.

What sort of business is allowed?

If you are eligible, your NEIS provider will assess the business idea to make sure it meets the business eligibility criteria. This means your proposed NEIS business:

- cannot already be operating on a commercial basis
- will be independent
- is lawful and capable of withstanding public scrutiny
- has been assessed as commercially viable by the NEIS provider
- is not based on the purchase or takeover of an existing business
- will not compete directly with existing businesses unless it can be demonstrated that there is an unsatisfied demand for the product or service, or the product or service is to be provided in a new way

- will be established, located and operated solely within Australia
- will be structured so you have and will maintain a controlling interest over the NEIS business for the duration of your time in NEIS
- will not be a not-for-profit business unless otherwise agreed to by the Department of Employment.

Purpose

To allow employers to register non-compulsory occupational clothing and allow employees to claim the cost of such clothing as a tax reduction.

Overview

Registered uniforms attract the following benefits.

- Employers are exempt from Fringe Benefit Tax on any contributions they make toward the uniform.
- Employees are eligible for tax deductions for expenses incurred in the rental, purchase or maintenance of approved non-compulsory occupational clothing.

The level of tax deductions is determined by the Australian Taxation Office.

To be approved, the uniform design must meet the requirements of the Approved Occupational Clothing Guidelines. Here are some hints to help you do that.

- The uniform must be a complete outfit, eg dress, shirt and trousers, shorts, and/or skirt.
- A company identifier (discrete logo/ name/ initials) must be on all items in the uniform, including accessories.
- For garments, the identifier must be at least 80 per cent of a four cm square, or for accessories, such as a tie or scarf, a one cm square.
- Identifiers must be in a contrasting colour to the garments they are attached to in order to be seen and legible from two metres away
- Identifier must be permanently attached to each garment (eg. embroidered, iron on, heat seal)
- A maximum of eight colours (which includes different shades of a colour and excludes those found in the identifier) for the entire garment range is allowed
- The number of colour/pattern/print combinations permitted is limited by the number of employees in a class (see paragraphs 31-32 of the Approved occupational clothing guidelines).
- Where a variation on a uniform is worn by different groups in an organisation, there must be a common theme between these groups or classes of employees and the male and female uniform
- The uniform must be appropriate for the duties of the employee.

Limitations

The following items cannot be included on the non-compulsory uniform register:

- compulsory uniforms
- occupation-specific clothing such as a chef's check pants and white shirt
- protective clothing.

To increase foreign investment in the Australian venture capital sector.

Overview

Fund managers seeking to raise a new venture capital fund of at least \$10 million for investing in Australian businesses with assets of up to \$250 million may be eligible for VCLP registration. Registration entitles a fund to flow-through tax treatment. Further, eligible foreign limited partners receive a capital gains tax exemption for gains made on eligible investments.

Australian businesses with assets of less than \$250 million may be able to access capital from funds registered under this program if their primary activity is not finance or property development.

What does it offer?

Partnership entitles a fund to flow-through taxation treatment. Further, eligible foreign investors in the fund are exempt from capital gains tax on their share of any profits made by the fund. The manager is entitled to claim their carried interest in the fund on capital account rather than revenue.

The extent of the tax benefit depends upon a number of factors. Venture Capital Limited Partnership participants should seek professional tax advice.

Limitations

You must have:

- used approved child care during the year
- been eligible for Child Care Benefit (entitled at a rate of zero or more)*
- passed the Child Care Benefit work, training, study test (for the purpose of the rebate)

Purpose

To provide exporters with an up-front exemption from Customs duties and other taxes (apart from excise taxes but including the Goods and Services Tax) on eligible imported goods.

Overview

The Tradex Scheme provides an up front exemption from customs duty and GST for eligible imported goods that are to be subsequently exported. The kinds of imported goods covered by Tradex include those that are:

- exported without mixing with other goods (eg exported in the same condition as imported, or exported having undergone processing or treatment that does not involve any mixing with other goods); or
- mixed with other goods and subjected to a process or treatment, after importation, and then exported;
- incorporated in other goods after importation and then exported; or
- otherwise mixed with other goods (eg simple assembly with other components or the incorporation of other goods in the imported goods) and then exported.

Limitations

When you apply for your Tradex order you must meet the following eligibility criteria:

- 1.You intend to import nominated goods that are to be subsequently exported; and
- 2.The requirements of the Tradex Regulations are met in relation to the nominated goods; and
- 3.The nominated goods will be exported within one year after entry into home consumption, unless an extension of time is approved; and
- 4.You have adequate record-keeping and accounting systems in place in respect of the nominated goods to track them until they are exported (these records must be retained in accordance with the Act).

Overview

Perpetual operates an annual IMPACT Philanthropy Application Program to support many of our clients and co-trustees in making decisions on where their distributions could be directed.

This program recognises the importance of the philanthropist, good grant making and governance in building a healthy and responsive charitable NFP sector, and is an opportunity for charitable organisations to demonstrate the quality of their work and mission.

Past funding has been provided for a wide range of projects at different developmental stages including; pilot and existing projects, capacity building requests and support for early career researchers.

The following will not be considered for funding:

Charitable Status

To be eligible for funding from the trusts and endowments that are managed by Perpetual, your organisation must have at least one of the following:

- Be a registered charity on the ACNC register
- Australian Taxation Office Deductible Gift Recipient (DGR1) endorsement (covered by Item 1 of the table in section 30-15 of the Income Tax Assessment Act 1997).

This Small Grants Program supports strategies to benefit Australian communities.

Overview

The aims are to:

- alleviate the negative effects of poverty and disadvantage;
- demonstrate new ideas about how to address poverty and disadvantage;
- strengthen communities' abilities to deal with poverty and disadvantage.

Priority

Priority Areas

- communities experiencing social and economic exclusion with particular emphasis on Indigenous Australians,
- asylum seekers and refugees, and people living in isolated rural and remote areas of Australia,
- children and young people from disadvantaged backgrounds who lack the opportunity to improve their wellbeing,
- small, discrete projects that meet the needs of a community rather than supplementary funding for large projects. A small, discrete project will be considered to have a total budget of up to \$50,000.

The Poverty and Disadvantage Small Grants Program accepts applications on an ongoing basis, with no specific closing dates.

Limitations

Applications will be accepted for grants for charitable purposes from Australian incorporated organisations that have been endorsed by the Australian Taxation Office (ATO) as Tax Concession Charities (TCC).

If you are unsure of your organisation's tax status, check with your financial advisor or the Australian Government's ABN Lookup website.

If your organisation is not endorsed as a TCC, but you are an Australian incorporated organisation, you may still be eligible to apply as long as we can be satisfied that the nature of your project is charitable.

Eligibility for Individuals

The Myer Foundation and Sidney Myer Fund do not provide grants directly to individuals or unincorporated bodies.

If you fall within this category, an application for funding may be made through a funding partner that has been endorsed by the ATO as a Tax Concession Charity. If your funding partner organisation is not endorsed as a TCC, but is an Australian incorporated organisation, you may still be eligible to apply as long as we can be satisfied that the nature of the project is charitable.

Limitations

- Submissions will not be accepted from organisations that have received a grant in the last 12 months from The Myer Foundation or Sidney Myer Fund.
- Applications that have been previously unsuccessful cannot be resubmitted.
- Submissions will not be accepted from organisations that have not successfully acquitted previous grants.

Grants will not be made towards:

- Expansion or replacement of large vehicle fleets unless it is tied to new service delivery

- Vehicles primarily for the personal use of staff and/or that form part of a salary packaging arrangement
- Operating and maintenance costs

We may provide a grant to replace a vehicle previously purchased with a Lotterywest grant (if there are exceptional circumstances that have prevented your organisation from setting aside funds for its replacement).

Most importantly, we want to understand what your needs are. Please talk to us.

For vehicles that have been funded by the Disability Services Commission, a limit of \$15,000 per vehicle is applied for the cost of modifications. Please complete our Furniture and Equipment Form if your request is for vehicle modifications.

Your organisation may be eligible for a concession towards the cost of vehicle stamp duty. We encourage you to contact the Department for Planning and Infrastructure on 13 11 56 to find out if your organisation qualifies.

Example

Here are some examples of what our grants have helped:

- A community bus for a regional local government authority to take people to recreational activities
- A boat so that people in wheelchairs can go fishing
- A car to help provide community midwifery services to rural areas
- A tractor to assist an Aboriginal community's land maintenance program

Limitations

Eligibility

It is a general rule that the DSS can only enter into a Grant Agreement with an organisation that is a legal entity. If an organisation is not a legal entity and, if it so chooses, an eligible sponsor organisation may apply for funding on its behalf (refer to 'Sponsoring community groups that are not legal entities' below).

The following entity types meet the eligibility requirements to be invited to apply for a grant for this Activity:

- Incorporated Associations (incorporated under state/territory legislation, commonly have 'Association' or 'Incorporated' or 'Inc.' in their legal name)
- Incorporated Cooperatives (also incorporated under state/territory legislation, commonly have 'Cooperative' in their legal name)

- overseas travel, and
- activities for which other Commonwealth, State, Territory or Local Government bodies have primary responsibility.

To assist eligible people who have permanent and severe incontinence to meet some of the costs of continence products.

Overview

An applicant is eligible for CAPS if the applicant is five years of age or older and meets either one of the following requirements:

- The applicant has permanent and severe loss of bladder and/or bowel function (incontinence) due directly to an eligible neurological condition; OR
- The applicant has permanent and severe loss of bladder and/or bowel function (incontinence) caused by an eligible other condition, provided the applicant has a Centrelink or DVA Pensioner Concession Card entitlement.

Limitations

A person is eligible for CAPS if they are five years of age or older and meets either one of the following requirements:

- has permanent and severe loss of bladder and/or bowel function (incontinence) due directly to an eligible neurological condition; OR
- has permanent and severe loss of bladder and/or bowel function (incontinence) caused by an other eligible 'other' condition, and the person has a Centrelink Pensioner Concession Card or entitlement, whether as a primary cardholder or a dependent of a cardholder; OR
- has permanent and severe loss of bladder and/or bowel function (incontinence) caused by an eligible 'other' condition and the person has a Department of Veterans Affairs Pensioner Concession Card or entitlement, whether as a primary cardholder or a dependent of a cardholder.

A person is not eligible for CAPS if:

- They are not an Australian citizen or a permanent Australian resident.
- They are a high care resident in an Australian Government funded aged care home.
- They are receiving an Extended Aged Care at Home (EACH) or an EACH Dementia (EACHD) package and continence products are negotiated as part of the person's care plan.
- They are eligible for assistance with continence products under the Rehabilitation Appliances Program (RAP) which is available through the Department of Veteran's Affairs.
- Their incontinence is one of the following types:
 - Transient incontinence (not permanent);
 - Incontinence that can be treated with an existing conservative treatment regime (eg pelvic floor exercises or bladder re-training), medication or surgery;
 - Confined to night time bed wetting (enuresis).

- Their incontinence results from a condition other than an eligible neurological condition AND the person does not have a Centrelink or DVA Pensioner Concession Card entitlement.
- They are serving a prison sentence.

Equipment supported by the Grants scheme are;

- Vehicle Modifications: Grants up to \$7,500 are available to assist with equipment such as modified driving controls, wheelchair hoists, wheelchair / scooter carriers, and specially modified wheelchair accessible vehicles.
- Assistive Technology for people with a vision impairment: Grants of up to \$5,000 are available to assist with hardware or software that magnifies produces spoken output or presents information as Braille for other tactile formats.
- Assistive Technology for people with a communication impairment: Grants up to \$5,000 to assist with AT such as communication devices for personal safety including alarms and specialised computer hardware or software.
- Air Conditioners: A grant of up to \$1,500 (\$1,800 in regional areas) may be available to assist with one air conditioner to provide one area of respite for a person unable to regulate their body temperature (thermoregulatory dysfunction) because of their disability and is on low income (Level 1 only)
- Essential Independence Equipment (New): Grants are available to support people with long term disabilities living at home with essential equipment not currently available through any other government funding programs. Items such as electrically adjustable beds, wheelchairs, hoists, specialised seating and personal hygiene equipment will be considered.

Limitations

Not-for-Profit Organisations or Local Government Authorities can apply for Disability Equipment Grants on behalf of individuals. Applicant organisations are responsible for the purchase of the item/s requested and for the proper expenditure and acquittal of the grant.

- maintain appropriate business ethics and demonstrate a commitment to legal obligations including anti-bribery laws, both in Australia and overseas markets.

Ineligible Projects

A project will be deemed ineligible if:

- it is a devolved grant, that is, a grant requested by the applicant for the purpose of distributing funds to other parties who are not contractors to the project and who have not been clearly identified in the grant application
- the applicant is receiving any other Commonwealth Government financial support for the proposed project.

Purpose

To reduce crashes on Australian roads and to target those road locations where crashes are occurring.

Overview

Road crashes are a major cost to Australians every year. Black Spot projects target those road locations where crashes are occurring. By funding measures such as traffic signals and roundabouts at dangerous locations, the programme reduces the risk of crashes. Programmes of this sort are very effective, saving the community many times the cost of the relatively minor road improvements that are implemented.

The Black Spot Programme makes an important contribution in reducing the national road toll under the National Road Safety Strategy and Action Plan.

The Australian Government has committed \$500 million to the Black Spot Programme from 2014-15 to 2018-19, which includes an additional \$200 million over two years from 2015-16 to improve road safety across the nation.

The Government has broadened the programme's eligibility criteria for 2015-16 and 2016-17 to assist local communities to compete for the additional funding available over those two years.

Under the new criteria, the minimum Benefit Cost Ratio (BCR) for proposals has been reduced from 2:1 to 1:1. In addition, the minimum crash history of sites has been reduced from 3 to 2 casualty crashes over five years or 0.13 casualty crashes per kilometre per year over 5 years.

The criteria has also been amended to allow more funding for the proactive treatment of unsafe roads. Consultative Panels will be able to allocate up to 40% of funding to sites on the basis of a road safety audit.

The Government has also guaranteed that at least 50 per cent of funding provided over the next two years will be dedicated to fixing roads in regional Australia.

Community groups, motorist organisations, industry organisations, councils and individuals are invited to nominate Black Spot sites around Australia to be considered for treatment.

The Community and Industry Engagement program (CIE) will provide funding to develop and implement waste management projects and initiatives that promote the diversion of waste from landfill. It will also provide funding for events that promote and recognise the adoption of better waste management practices and achievements.

Overview

The CIE is an initiative of the State Government's Waste Authority which allocates up to \$690,000, funded by the Waste Avoidance and Resource Recovery Account (WARR Account).

CIE builds on the achievements of the strategic partnerships program, which concluded in June 2016. It seeks to increase engagement with the Waste Authority's key programs and support communication of the Waste Authority's key messages by peak organisations to the stakeholders they represent.

The Waste Authority's key messages include:

It also means that you will be planting plants from a genetic stock which is already accustomed to living in the specific environmental conditions of your project area and are therefore likely to have higher survival rates. While not an essential criterion, funding priority will be given to projects that incorporate the use of local provenance plants for revegetation purposes.
7. Groups not registered for GST should include GST amounts into your budget.
8. Applicants can apply for administration expenses up to 10% of funds sought from NACC.

In addition, the CHSP will support older people or people aged 50 years and over, who are on a low income and who are homeless or at risk of homelessness as a result of experiencing housing stress or not having secure accommodation, through the provision of assistance with accessing care and housing

The objectives of the CHSP are to:

- Provide high-quality support, at a low intensity on a short-term or ongoing basis, or higher intensity services delivered on a short-term or episodic basis, to frail, older people to maximise their independence at home and in the community for as long as they choose, thereby enhancing their wellbeing and quality of life
- Support frail, older clients aged 65 years and over (50 years and over for Aboriginal and Torres Strait Islander people) through the direct service delivery of planned respite services, which will allow regular carers to take a break from their usual caring duties

You are eligible to apply for registration as an ACP if you produce in Australia at least one kind of automotive component annually for use as original equipment in at least 30,000 motor vehicles or 30,000 engines and the production value of the component was at least \$500,000 in the previous 12 months OR you produce in Australia original equipment components with a production value of at least \$500,000 annually, comprising at least 50 per cent of the production value of all automotive components produced.

You are eligible to apply for registration as an AMTP if you produce in Australia automotive machine tools or automotive tooling with a production value of at least \$500,000 annually, where at least 50 per cent of that value was for automotive machine tools and automotive tooling used to produce original equipment.

You are eligible to apply for registration as an ASP if you provide in Australia automotive services with a production value of at least \$500,000 annually, where at least 50 per cent of the production value was for services related to the production of motor vehicles or original equipment.

- The equipment which failed is not subject to replacement through insurance claim.
- No additional permits or approvals are necessary to install the new equipment.
- You provide evidence that you are unable to find immediate solutions from within the sector by borrowing equipment in the short term.

What can't you use the grant for?

- Replacement of equipment that has failed due to age or poor maintenance.
- Equipment that is subject to replacement under an insurance claim.

Conditions:

Emergency grants are only to assist stations who are off-air. You may not apply for a grant if your station is still broadcasting.

Priority

We will prioritise:

- Stations with a formal relationship with local emergency services organisations
- Stations with a small income. The CBF takes into account income from all sources, including other CBF grants
- Stations with cash reserves of less than \$100,000.
- Applications where it is demonstrated that your organisation or project partners are contributing in cash or in kind, such as through fundraising or volunteer labour.

EITAAP funding is available to assist with out-of-pocket travel and accommodation expenses only. Eligible sportspersons can apply for up to:

- a maximum of \$1,000 per financial year for eligible national championships; and
- up to a maximum of \$3,000 per financial year for eligible international competitions.

Applicants must note:

- Funding is provided for travel to get to the competition and return home.
- The competition venue must be 200 kilometres or further in distance from the applicants address.
 - If flying, the cost of a standard economy airfare can be claimed.
 - If not flying, the cost of petrol, a coach or train ticket can be claimed.
- Accommodation is only provided for any out-of pocket expenses to the applicant.

To be eligible to apply for an EITAAP grant, an indigenous sportsperson and their sponsoring organisation must meet the following criteria:

- Be an Aboriginal or Torres Strait Islander. Note that if you have not received EITAAP before, you must include a Confirmation of Aboriginality with your application. These documents can be obtained from most local Indigenous organisations, land councils or health centres.
- Be participating as an athlete, coach, manager or official in:
 - An official national championship endorsed by the relevant ASC recognised national sporting organisation or national sporting organisation for people with a disability(NSO/NSOD) or School Sport Australia (SSA); or
 - An international competition as a member of an official Australian team endorsed by an ASC recognised NSO/NSOD or SSA.
- Be 12 years or older at the time of the competition (exceptions may be made for SSA championships).
- Competing in junior or open level competitions.
- Have completed and submitted an EITAAP application before the event (or within two months of the completion of the event).
- Have out-of-pocket expenses for travel and accommodation, and need to pay these to your sponsoring organisation and/or you are organising the travel and/or accommodation yourself.

You are not eligible for EITAAP if you are a sportsperson who is:

- Not paying a levy to attend the competition.
- Not paying for travel and/or accommodation.
- Under the age of 12 at the time of the competition.
- Participating in a competition in your home town (within 200 kilometres in distance).
- Participating in a competition that involves prize money.
- Participating in a professional event.
- Participating in a commercial tour (example, Sports Travel Australia).
- Participating in an Indigenous-only team.
- Participating in a competition where there is no clear selection process.
- Participating in a senior/masters division or competition.

- Be participating as an athlete, coach, umpire or referee in:
 - an official state championships endorsed by the relevant Australian Sports Commission (ASC) recognised national sporting organisation (NSO), or
 - an official state school sport championship endorsed by a School Sport Australia member body, or

- an official national championships endorsed by the relevant ASC recognised NSO, or
- a national school sport championships endorsed by School Sport Australia
- an international competition as a member of an official Australian team, endorsed by an ASC recognised NSO or School Sport Australia.
- Be living more than 125km from the championship venue, and travelling greater than 250km return to participate in the nominated championship.
- Must complete and submit application to the ASC prior to the nominated championship commencing.
- Must not have received a Local Sporting Champions grant for an application submitted in the same allocation year (1 March - 28 February).
- Must not have received \$500 or more in federal government funding for the nominated championship.
- Must not be participating in a professional competition that involves prize money greater than \$500.

Note:

- Saved applications must be completed and submitted prior to the championship.

Grants of \$5 per person per night up to a maximum of \$15 000 are available to eligible organisations who conduct a tour:

- held in the March – November period (tours held in December, January and February are not eligible)
- attracting more than 40 people from outside Tasmania
- staying five nights or more in paid commercial accommodation (hotel, motel, B&B, cabin)
- spending 40% or more of the tour in regional areas (outside Launceston and Greater Hobart).

Motorhome, caravan, camping and walking tours may also be eligible, but only for the days that participants spend in paid accommodation, and with the same ratio of 40% paid accommodation in regional areas.

Limitations

You don't have to be Tasmanian to apply - Applicants can be based in Tasmania or elsewhere in Australia.

But you do have to be... An incorporated association or a company limited by guarantee, or be auspiced by one. If your application is successful you will need to enter into a funding agreement with the Tasmanian Government to receive your grant.

Reasons you may not be eligible for a grant Grants are not available to individuals or businesses that create and conduct tours as their commercial operations. Our funding programs don't support conferences, conventions, symposiums, exhibitions, theatrical productions, concert series, touring arts products, trade fairs, fundraising events, markets, expos and events that are primarily a showcase for stall-holders to demonstrate, promote or sell services or products.

If your event already receives Events Tasmania funding through a Major Event Partnership you are not eligible for funding from the 2015 Grants Program for the same event.

Funding can cover project costs such as artist fees, artist travel, materials, promotional costs, documentation or venue hire.

- Applicants and participants must be aged 12 – 26 and live in regional WA.
- Each project must include:
 - Direct organisers - at least 2 young people (as the applicants)
 - Direct participants - at least 6 young people (larger communities should have at least 10 young people)
 - Indirect participants - at least 15 young audience members or attendees
- young people need to have come up with the idea, write the application and will participate as well as help coordinate the whole project.
- You must involve an experienced artist or artists who will teach young participants some new artistic skills.
- Funding can cover project costs like artist fees, artist travel, materials, promotional costs, documentation or venue hire.
- Drug Aware YCulture Regional is open all year round and you can apply twice per calendar year.
- You can submit an application at any time but it must be received by Country Arts WA at least 6 weeks before your project is planned to start.
- You must call the Project Officer to discuss your idea and submit a draft application, well before your final application is due.
- Your project must be supported by a community-based organisation that has an ABN to manage the money for your project. This is what's known as an "auspice organisation".
- All projects must be smoke, drug and alcohol free.
- Drug Aware YCulture Regional will not fund projects that have already happened in your community.

- Religious activities, where the applicant project involves religious instruction.

- Organisations outside Australia.
