


LAKE PRESTON TRAIL - VIEWING PLATFORM

Shire of Waroona Town Planning Scheme No.7 1996 NOTICE OF LOCAL PLANNING POLICY FOR PUBLIC INSPECTION

Notice is hereby given that the Shire of Waroona has resolved to advertise for public comment a revised Draft Planning Policy titled Home Based Business.

LOCAL PLANNING POLICY 11.0 HOME BASED BUSINESS

Operational issues in the application of the policy include:

- Inconsistency with anti-competitive business legislation;
- Legal status of home based business permits;
- Inconsistency with other Local Planning Policies; and
 Inconsistency with the Town Planning Scheme (TPS).

In order to address the above issues a number of changes have been made to the policy including:

- Updating definitions of land uses in accordance with the Town Planning Scheme;
- Clarifying use interpretations of home based businesses;
- Modifying approval and renewal processes to be consistent with the Town Planning Scheme; Removing provisions relating to commercial impact of home based businesses; and
 - Removing provisions relating to applicants undertaking consultation.

The Policy is intended to be adopted as a formal Planning Policy pursuant to Clause 2.4 of the Shire of Waroona Town Planning Scheme No. 7. Copies of the Policy are available for inspection at Council's office 52 Hesse Street, Waroona, Monday to

Friday, between 9am and 4pm or on Council's website www.waroona.wa.gov.au. Submissions on the Policy may be made in writing and should be lodged with the Shire on or before 29 September 2015. Your written submission(s) should quote "Draft Home Based Business Policy" in the title and be addressed to the Chief Executive Officer, Shire of Waroona, PO Box 20, Waroona WA 6215

All submissions received will be considered by Council in its determination of the Policy for final adoption.

ALCOA WAROONA SUSTAINABILITY FUND 2015 GRANTS

Community groups and organisations in the Shire of Waroona are invited to submit applications for grants from the Alcoa Waroona Sustainability Fund.

The Sustainability Fund purpose is to fund facilities and projects with enduring value for the communities surrounding the Wagerup refinery. Funds will be allocated to community organisations, initiatives, processes and activities that contribute to the local government region known as the Shire of Waroona.

The Advisory Committee has set an upper limit of \$250,000 it may distribute in this round and the individual amount will be dependent on the strength of the applications, however, it is expected that no individual application will be less than \$10,000 nor exceed and amount of \$50,000.

To be eligible you must be an incorporated community group and/or organisation who is domiciled and provides services predominately within the Shire of Waroona including, but not limited to, Waroona, Lake Clifton, Preston Beach, Nanga Brook, Wagerup and Hamel.

Applications can be for a broad range of community development projects both large and small that make a positive contribution to the economic, social, recreational or environmentally sustainability of the communities within the Shire of Waroona.

Projects that attract matched or partial funding from other sources and promote the concept of co-location (where appropriate) will be encouraged.

BULLER ROAD REFUSE FACILITY



Gate fees and practices at the Buller Road Refuse facility have changed due to increased operational costs and environmental compliance requirements. Council passed the new fee structure at its special meeting on 4th August 2015 to adopt the 2015/15 budget.

Residents will still be able to use tip passes attached to rate notices and rural landowners can come into the Shire offices and collect their pass by showing their rate notice. Tip passes must be taken with you to the facility and shown at the gate as proof of residency of the Shire regardless of the type of waste being dropped off. The tip pass system is partly in place to differentiate between residents and non-residents so that non-residents can be charged to use the refuse

site. Therefore it is vital that you take your passes with you each time you use the facility however a grace period of approximately six months is in place until the necessity to bring tip passes each time becomes better known. Some items of waste such as green waste and scrap metal will not cost a tip pass to drop off however you should still bring your passes each time you attend the facility.

The Shire of Waroona is fortunate in that it operates its own landfill as this is becoming more and more uncommon throughout the local government industry. Council encourages users to recycle as much as they can which will reduce the amount of waste going into the landfill space and keep the landfill open for as long as possible, so as to take advantage of the lower disposal costs associated with the operation of a landfill compared to alternative disposal options. Council also has to ensure it can effectively rehabilitate the site once the landfill is closed and by being proactive in placing funds into reserve now ensures that when the time comes to close the site in the future, there are sufficient funds for site closure and rehabilitation.

Again, residents are encouraged to recycle as much as possible and utilise the local free markets. The local op shop and Lions club also are an option, taking good quality clean second-hand items.

ONELIFE SUICIDE PREVENTION GRANT



Last financial year, the Shire of Waroona successfully received funding from One Life to the tune of \$15,000 for two separate grant applications- one being for training and the other small grants. In August, the funding obtained for training was used to hold a Youth Mental Health First Aid workshop at the Waroona Community Resource Centre. The two-day training was delivered by the Brain Ambulance, catering to those working or living with adolescents, aged between approximately 12 and 18 years. The course taught participants how to assist adolescents who are developing a mental health problem or in a mental health crisis. Course participants

learnt about adolescent development, the signs and symptoms of the common and disabling mental health problems in young people, where and how to get help when a young person is developing a mental illness, what sort of help has been shown by research to be effective, and how to provide first aid in a crisis situation. The community of Waroona was well represented with attendees from our local sporting groups, school staff, volunteers, those working with at risk youth and those who have a child suffer from a mental illness.

The remainder of the funding will be used to undertake a collaborative project with the Shire of Waroona and the Waroona District High School to deliver essential training programs to youth in the local community and also used towards R U OK? Day which is held on the 10th of September. R U OK is an Australian not-for-profit suicide prevention organization, it is a day dedicated to remind people to ask family, friends and colleagues the question, "R U OK?", in a meaningful way, because connecting regularly and meaningfully is one thing everyone can do to make a difference and even save lives. On this day the Brain Ambulance will be delivering a Youth Mental Health workshop to all Year 10 students teaching them how to provide mental health first aid to their friends.

The Shire of Waroona is one of only two council to successfully receive One Life funding for their projects and the only one to receive a grant in both offered.
