INCOME

Rating

The 2025/26 budget is prepared on an overall rate income of \$6,525,928 provided for general purpose expenditure. The overall rate increase is calculated as 3.50%, which is an increase of 0.25% more than predicted in Council's Long Term Financial Plan (LTFP). This has largely been because of the continued compounding impact of past rate freezes (due to COVID19) and below-forecast increases, which created a structural gap in funding. Additionally, elevated inflation and rising service delivery costs—particularly increases in wages, materials, and insurance—have placed additional pressure on operating expenditure, necessitating a modest adjustment above the LTFP forecast to maintain financial sustainability and service levels. The rates increase is considered to be reasonable and fair to the community based on rising costs and inflation rates. Minimum rates have been increased from \$1,343 to 1,390.

To ensure rates objectivity and fairness is achieved across the Shire as a whole, and to achieve an equitable level of rating between commercial properties within both the GRV and UV rating categories, in 2023/24 Council introduced two new differential rate codes for UV Mining & Industrial and UV Intensive Agriculture. The differential rate code is applied to properties located outside of the townsite that are held for light or heavy industry, mining, exploration, extractive industry (where no road contribution is applied), renewable energy or intensive agriculture use. Additional funds raised from differential rating provides funding for the maintenance of infrastructure as a result of heavier road use.

Rubbish / Recycling

A new model for waste was introduced in 2023/24. Previously, the waste levy and kerbside collection fees were combined as an annual levy. However, to comply with the *Waste Avoidance and Resource Recovery Act 2007*, ensuring all ratepayers are adequately contributing to waste operations, all rateable assessments (per assessment, not per lot) are charged a waste operations levy. The kerbside collection levy will be charged separately. The waste operations levy will be \$243 and the kerbside collection charge for a standard bin service \$190. Tip passes for properties located within a townsite include 12 passes. Properties which are located outside of the kerbside collection service (rural) will receive 24 passes per annum. Each pass allows for the disposal of 1m³ of waste (conditions apply).

User Fees & Charges

User fees and charges income is budgeted at \$1,026,836 and includes income from Recreation & Aquatic Centre (WRAC) charges, town planning and building fees, and hire of Shire facilities etc. Income from the waste operations levy, kerbside collection charge and bulk bins is budgeted at \$1,470,647.

Contributions to Capital Projects

Contributions to capital projects is budgeted at \$3,315,271 and includes estimated grants and contributions to fund projects such as Railside Park, Capital Road Program, Phase 1 of the Peel Trails project and various other capital projects.
