Local Government Legislation Amendment Act 2019

Annual Report of Training Conducted by Elected Members of the Shire of Waroona for Year Ended 30 June 2020

Pursuant to s.5.127 of the *Local Government Act 1995*:

- (1) A local government must prepare a report for each financial year on the training completed by council members in the financial year.
- (2) The CEO must publish the report on the local government's official website within 1 month after the end of the financial year to which the report relates.

Councillors Mason, Odorisio, Snell and Vitale are required to complete the WALGA Council Member Essentials Compulsory Training by 18 October 2020.
