SHIRE OF WAROONA APPLICATION FOR APPROVAL TO CONSTRUCT / RENDER ALTERATIONS TO FOOD PREMISES *Food Act 2008*

This application form is required if you intend to construct, or render major alterations, to a food premises pursuant to Part 9 of the *Food Act 2008*. **This form is to be accompanied by the required plans.**

The *Food Act 2008* also requires food business proprietors to comply with all provisions set in the Food Standards Code. Guidance on the design, construction and fit-out of food premises can be found in Australian Standard *AS 4674-2004 Design, Construction and Fitout of Food Premises*. Further guidance may also be found in the Building Code of Australia. If the food premises is to be fitted with a commercial exhaust canopy system it is to be constructed and installed in accordance with *AS 1668.2—2002 The Use of Ventilation and Air conditioning in Buildings*.

Two copies of a scaled floor plan and specifications of the food premises is to be submitted with this application. Please tick off the following:

- The proposed use of every room.
- The structural finishes of every wall, floor and ceiling.
- The position and type of every fitting/fixture, including distances from floors/walls.
- All sanitary conveniences, change rooms, storerooms, ventilating systems, drains, grease traps and provision for waste disposal.
- Plans and specification of the commercial mechanical exhaust canopy system if applicable, and it is to comply with AS 1668.2—2002 *The Use of Ventilation and Air conditioning in Buildings*.

Note: Construction cannot commence until you receive approved plans which includes conditions of approval. Operation is not to commence prior to final approval. Contact the Shire on 08 9733 7800 upon completion of construction to make an appointment for final inspection. Most food businesses are also required to be registered. Application for registration of food business will need to be completed.
