It is time again for swimming pool safety barrier inspections. The Shire began inspections at the end of April but had to stop due to Covid-19. The letters will be sent out shortly, with inspections commencing the end of July 2020, on Tuesdays and Thursdays.

Your assistance in providing access on the day of your inspection, by having someone at the property to provide access or by leaving a gate unlocked and placing your dogs in a secure area, will be appreciated.

The inspection is covered by your rates contribution each year, however if the safety barrier is not compliant, or access was not available at the arranged time, you will receive an invoice for the follow-up inspection.

To help you make sure the barrier is compliant upon the first inspection, you will receive a booklet with an explanation and diagrams of the requirements with your letter.

## WAROONA 2030 - STRATEGIC **COMMUNITY PLAN**

In preparation for Waroona 2030, the Shire of Waroona embarked on its biggest community engagement campaign, seeking the views of its residents in Waroona, Hamel, Lake Clifton and Preston Beach.

Under the theme of "Our ideas and imagination are shaping Waroona", extensive consultation was conducted reaching over 400 community members across the Shire of Waroona. Consultation included a district wide survey, coffee conversations with 18 community groups and key stakeholders, a facilitated workshop with local businesses, a workshop with Councillors and key staff members, and five community workshops.

Across these five workshops, approximately 1,000 ideas were contributed and 280 were noted as being important to a community member in some way. While each district had specific suggestions, 10 common themes were highlighted - creating events and tourist attractions | developing walk and bike trails enhanced caravan and camping accommodation | increased local and tourism signage more activities for youth community and night markets | regular streetscaping and verge maintenance | appealing entry statements | better access to healthcare professionals | public transport. The community consultation enabled the Shire to identify what is important to the community, both now and into the future. It has set out an ambitious but achievable vision, featuring the shared values, aspirations and priorities of the community over the next 10 years.

The COVID-19 impact has been severe to many, and therefore Council has resolved to not have an increase in rates or service charges this financial year. The Federal Government distributed \$288,000 of funding to council to bring some projects forward to stimulate jobs which was very welcomed. However this amount is much less than the normal road funding the Shire would normally receive under the State Government's Commodity Routes Supplementary Fund Programme which has not been provided this year, which has added further pressure on our budget.

While some of our hospitality businesses have had a challenging time, I feel we are emerging from what could have been considerably worse. Our Shire has until now not recorded a case of the virus and it seems that we may have the worst behind us. From here we try and encourage visitation to our Shire and region and capitalise on what will potentially be a great day trip from the metro and the fact that holiday makers will be looking at WA to enjoy a break and relax at home. ### LONG-TERM MASTER PLAN TO UPGRADE DRAKESBROOK CEMETERY

A long-term Master Plan to upgrade the Drakesbrook Cemetery was endorsed by the Waroona Shire Council last week.

With the current grave site area having capacity for as much as forty years, the master plan identifies future upgrades that can now be implemented and staged over the next ten years and beyond.

Shire President, Cr Mike Walmsley said that it is a very important site that deserves ongoing care and respect.

"While there are only around fourteen burials per year, naturally the site is of great importance with many people paying their respects to those that have passed but are still remembered".

The master plan includes nine main strategy areas:

- 1. Mitchell Avenue entrance precinct
- 2. Car park & public facilities
- 3. Potential Future function centre
- 4. Niche wall area
- 5. Storage area
- 6. Existing grave sites area
- 7. Garden and quiet space
- 8. Boundary buffer
- 9. Future grave site development
