#### **Cemeteries Act 1986 Local Government Act 1995** Shire of Waroona Adoption of Drakesbrook Cemetery Local Law 2021

The Shire of Waroona has resolved to make the Shire of Waroona Drakesbrook Cemetery Local Law 2021.

The purpose of this local law is to provide the rules for the regulation and management of Drakesbrook Cemetery.

The effect of this local law is intended to result in supervision and regulation of Drakesbrook Cemetery; prevention and mitigation of nuisances at Drakesbrook Cemetery; and regulation of conduct at Drakesbrook Cemetery to enhance environmental conservation, public safety, convenience and amenity.

A copy of the local law may be inspected at or obtained from the Shire Administration Office at 52 Hesse Street, Waroona, between 8.30am and 4.00pm Monday to Friday. A copy is also on the Shire's website www.waroona.wa.gov.au

This local law was published in the Government Gazette on 5 July 2021 and will come into operation on 19 July 2021.

#### **Preston Beach Foreshore Restoration Works**

The Shire of Waroona together with the Preston Beach Volunteer Rangers have been working together for the past eight years to manage foredune erosion at Preston Beach. The Shire was successful in obtaining funding from Coastwest to carry out the works during this financial year as has been the case in previous years. The funding is vital to the success of the rehabilitation effort and the Shire recognises that careful management of the costal environment is important to ensure coastal dunes are protected, particularly in areas where vegetation is poorly established and represents an increased risk of sand blowouts and

The Shire believes that one of the most effective ways of managing this problem is dune brushing, which rebuilds the dune and prevents vehicular access. The residents of Preston Beach dispose of suitable green waste within a secure compound for nine months of the year which is then placed in blown out areas. The green waste catches and holds windblown sand and assists in rebuilding the foredune system while also preventing access.

The Shire would like to thank the Preston Beach Volunteer Rangers and the Preston Beach Progress Association for their assistance with this years Foreshore Restoration Works. The Shire would also like to thank Coastwest for funding the project which has been vital to ensure the success of the rehabilitation works.
