#### **Cemeteries Act 1986** Local Government Act 1995 Shire of Waroona Adoption of Drakesbrook Cemetery Local Law 2021

The Shire of Waroona has resolved to make the Shire of Waroona Drakesbrook Cemetery Local Law 2021.

The purpose of this local law is to provide the rules for the regulation and management of Drakesbrook Cemetery.

The effect of this local law is intended to result in supervision and regulation of Drakesbrook Cemetery; prevention and mitigation of nuisances at Drakesbrook Cemetery; and regulation of conduct at Drakesbrook Cemetery to enhance environmental conservation, public safety, convenience and amenity.

A copy of the local law may be inspected at or obtained from the Shire Administration Office at 52 Hesse Street, Waroona, between 8.30am and 4.00pm Monday to Friday. A copy is also on the Shire's website www.waroona.wa.gov.au

This local law was published in the Government Gazette on 5 July 2021 and will come into operation on 19 July 2021.

#### **Murray-Waroona Resource Sharing Joint Statement**

On 22 and 27 July respectively, the Shires of Murray and Waroona resolved to recommit their focus on a large number of economically significant major projects that are either in progress or under development.

From a regional perspective, the Murray-Waroona-Harvey Water Security Study is being undertaken and the growth of the agri-business sector is being facilitated especially through Western Australian Food Innovation Precinct efforts.

From an individual Shire perspective, projects include:

Murray:

- Western Australian Food Innovation Precinct build and activation (\$35 million) Redevelopment of the Exchange Hotel
- (\$5 million) Stages Two and Three of the Pinjarra
- Heavy Haulage Deviation (\$70 million) Pinjarra Revitalisation Strategy
- (\$10 million) Implementation of the Dwellingup Futures Sustainability Strategy
- Sir Ross McLarty future development (\$13 million)
- Equine Industry development including significant capital upgrades to the racing and harness tracks and the Murray Regional Equestrian Centre under cover arena (\$45 million) · Advocating for local health services and
- upgrades to Murray District Hospital Determination of the feasibility of recommencing rail from Pinjarra to
- Dwellingup North Dandalup Recreation Precinct
- redevelopment New Local Planning Scheme preparation

#### Waroona:

- Waroona Town Centre Revitalisation Strategy implementation (\$10 million)
- Waroona Community Precinct implementation (\$5.5 million) with the first \$3 million component to commence soon
- Drakesbrook Weir redevelopment (\$2.3 million) with first \$750,000 component to start soon
- Transforming the Waroona 'old' Agriculture Department building into a regional environmental hub (\$500,000)
- Development of Waroona Lakes hiking and bike trail from Drakesbrook Weir to Lake Navarino and Lane Poole Reserve (\$3 million)
- Activation of redundant Alcoa land and use of infrastructure assets for community recreation and economic purposes

#### **DEAN UNSWORTH** CHIEF EXECUTIVE OFFICER

#### PRECINCT CONCEPTS CONSIDERED BY COMMUNITY

Local residents and business owners recently braved the cold and wet weather to attend two information sessions at the Waroona Memorial Hall and provide their input to the latest concept plans for the Waroona Community Precinct.

The Shire of Waroona has engaged landscape architect firm, EPCAD, to progress the Precinct planning, including a detailed review of the location and earlier community feedback to prepare three concept sketches for consideration.

Over two sessions on Thursday 29 July, Howard Mitchell and John Brinkhurst from EPCAD explained the detailed thinking behind the concepts, and how important factors have been incorporated such as pedestrian linkages to the town centre, inclusive design for people with mobility challenges and integration of the various components so there is something for all ages.

"We were here to listen to the community, understand how people want to see the Precinct develop and hear what is important for Waroona, " said Mr Mitchell.

Community members contributed a broad range of ideas and suggestions including grant from the Federal Government and the importance of ensuring a uniquely

Waroona feel to the Precinct which reflects the connection to water, agriculture, nature and local history. Interesting discussion was held about the way the pump track and skating elements could be seamlessly integrated into the area and the preferred locations for playgrounds and event spaces.

Director of Planning and Sustainability for the Shire, Rod Peake, said attendees provided important insights and shared some great examples of other parks and facilities.

"Our community is really engaged in this project and their suggestions will help inform what takes prominence in the Precinct and how local families will use the space. he said

Once the preferred option, or combination of options, has been confirmed, EPCAD will commence work on the detailed design for the Precinct. With \$3 million of funding already committed to the project, it is anticipated that construction will commence in March 2022. Funding has been confirmed with \$1.3 million from the WA government, \$450,000 from Lotterywest, \$450,000 from the Alcoa Waroona Sustainability Fund, \$450,000 from the Shire, \$300,000 from the Local Roads and Community Infrastructure local fundraising efforts.
