### **President's Report**



The Shire's Chief Bush Fire Control Officer has taken into consideration the current conditions and has shortened the unrestricted burning season. Effectively, this means that from the 18th of May you will no longer require a permit to burn. This still requires everyone that conducts a burn to do it responsibly and to supervise a fire, so it won't become uncontrolled. If you have any doubt or are unsure of your responsibilities, please seek advice from our designated bushfire control officers.

Later this month a ceremony will be held to mark the commencement of our Town Precinct area. This project has had encouraging community consultation and support from the solid base of engaged residents who have helped shape the concepts and plans for what will be a great area for our residents and visitors to our town. Council looks forward to seeing this area come alive and to see it becoming the first stage in revitalising the town centre.

Council is currently undertaking reviews of some of our local laws in accordance with the Local Government Act. These laws are fundamental to good governance and are there to guide Council officers in compliance. Reviewing the local laws helps keep them relevant and consistent with community expectations. Being on the right side of compliance with our local laws saves many headaches going forward for everyone.

With the oncoming winter period, our busy outside crew are coming to the end of the road construction

period. They always appreciate the patience displayed as road users pass through when they are working. The demands on our roads are evident by some of the reporting that officers undertake through the traffic counters that are placed in areas around our Shire. All this information helps formulate the budget process to help Council stay on top of maintenance and which roads need reconstruction

I found it personally humbling to witness the support for the Anzac services this year. In a time where some people are finding life challenging given the events that have taken place over the last two years, people found time to reflect on what others sacrificed to enable us to enjoy the freedoms and the quality of life we have. The Shire of Waroona has a range of regulations, policies and local laws it upholds to support the delivery of the community's goals and vision in the Strategic Community Plan. There are also other State and Federal laws, which protect the environment and have an impact on planning and development matters.

This is to ensure we work together, to protect the wellbeing of the community and our natural assets for future generations.

PLEASE REMEMBER – you need to obtain written consent **BEFORE** clearing any natural vegetation or mature trees!

Written permission is also required - before undertaking any activity in a Shire Road Reserve.

It is also illegal to take any wood alive or dead from a Shire Reserve.

For the clearing of vegetation, you can contact the Shire's planning services. A Shire officer will work with you to establish if you need to get an assessment done on your site, in relation declared and engendered flora and fauna, as well as wetlands and waterways. Your property may also be subject to a 'conservation convent' preventing land clearing. Please be Aware: Property owners and machinery operators, who clear land without approval may be prosecuted, fined and/or ordered to rehabilitate.
