Notice is hereby given that the Shire of Waroona has resolved to advertise for public comment a revised Draft Planning Policy titled Ancillary Accommodation.

### LOCAL PLANNING POLICY 7.0 ANCILLARY ACCOMMODATION

The proposal is to amend the Local Planning Policy - No. 7 to guide the developed of Ancillary Accommodation within the Shire of Waroona. It is proposed to update the policy as follows:

1. Incorporate changes to State Planning Policy 3.1 Residential Design Codes.
2. Link the advertising of planning applications for Ancillary Accommodation to Local Planning Policy 1 – Community Consultation.
3. Add additional provisions to control the potential impact that Ancillary Accommodation may have within the Shire.

The Policy is intended to be adopted as a formal Planning Policy pursuant to Clause 2.4 of the Shire of Waroona Town Planning Scheme No. 7.

Notice is hereby given that the Shire of Waroona has resolved to advertise for public comment a revised Draft Planning Policy titled Waroona East Hills Development.

### LOCAL PLANNING POLICY 27.0 WAROONA EAST HILLS DEVELOPMENT

The policy is proposed to be amended to address issues and inconsistencies that have arisen in the day to day application of the policy. Changes proposed to the policy include;

- Updated formatting to be consistent with the reviewed policy suite of the Shire of Waroona;
- Correcting inconsistencies with and references to the Town Planning Scheme and *Planning and Development (Local Planning Schemes) Regulations 2015*;
- Deleting obsolete provisions that have been superseded by updates to the state planning framework; and
- Allowing for greater flexibility in considering development that does not impact on the amenity of the Darling Scarp.

The Policy is intended to be adopted as a formal Planning Policy pursuant to Clause 2.4 of the Shire of Waroona Town Planning Scheme No. 7.

### Town Planning, Building Permit and Septic Tank Applications:

The replacement or restoration of buildings and infrastructure destroyed or damaged by the fire may require the approval of Council.

Shire residents are encouraged to contact the Shire's Development Services team on 9733-7800 or visit the Shire offices located at 52 Hesse Street Waroona, if you are unsure if you are required to obtain the relevant approvals. General information on bushfire recovery is also available on the Shire's website on [www.waroona.wa.gov.au](http://www.waroona.wa.gov.au).

### Bushfire Recovery Assistance:

A bushfire "One-Stop-Shop" has been established at the Waroona Community Resource Centre to provide the community with assistance in the recovery process. ### Property Visits:

Officers from the Shire as well as officers from the City of Mandurah and the Shire of Murray have started visiting all the properties that have been impacted upon by the recent fires. The purpose of the visit is to provide residents with an information pack containing relevant information on the recovery process and what assistance may be available. In addition officers will be undertaking an overall assessment of fire damage on the property and gathering information from residents.
