#### SHIRE OF WAROONA LOCAL PLANNING SCHEME NO.7 1996 NOTICE OF LOCAL PLANNING POLICY FOR PUBLIC INSPECTION

Notice is hereby given that the Shire of Waroona has resolved to advertise for public comment a revised Draft Planning Policy titled Sea Containers.

LOCAL PLANNING POLICY 18 SEA **CONTAINERS** 

The policy is proposed to be amended to address

issues and inconsistencies that have arisen in the day to day application of the policy.

Changes proposed to the policy include; Re-wording of the purpose of the policy Updating references to the Scheme and planning legislation:

Updating the format of LPP18 to conform with the Shires current local planning policy manual; Removing the list of zones in which sea containers may be permitted;

Removing the maximum number of sea containers permissible on a single lot; and

Removing standard approval conditions from LPP18.

Removal of the 3m setback requirement. Copies of the Policy are available for inspection at Councils office 52 Hesse Street, Waroona, Monday to Friday, between 9am and 4pm or on Councils website www.waroona.wa.gov.au.

Submissions on the Policy may be made in writing and should be lodged with the Shire on or before 5 January 2018. Your written submission(s) should quote Draft Sea Container Policy in the title and be addressed to the Chief Executive Officer, Shire of Waroona, PO Box 20, Waroona WA 6215 or e-mailed to warshire@waroona.wa.gov.au.

All submissions received will be considered by Council in its determination of the Policy for final adoption.

#### LOT 356 BEACHCAST CLOSE, **PRESTON BEACH - APPLICATION** FOR PLANNING CONSENT FOR NBN **INFRASTRUCTURE**

Council has received an application for Planning Consent for NBN (National Broadband Network) infrastructure at the above property in order to provide NBN coverage to Preston Beach. The application proposes a 30m high concrete monopole, with four (4) panel antennas, eight (8) remote radio units, and one (1) parabolic antenna dish mounted on the proposed mast. An equipment shelter at ground level and ancillary equipment are also proposed. The total structure height above ground level will be 30m. Telstra and Optus, which have existing infrastructure on the lot, also propose facility upgrades. Telstra proposes to co-locate the existing mobile

phone base station facility with additional upgrades including, three (3) panel antennas, on the proposed 30m concrete monopole. Telstra also proposes to remove the existing 15m high monopole and relocate their equipment to the new facility.

Optus proposes to co-locate a new mobile phone base station facility on the proposed concrete monopole consisting of three (3) panel antennas, RRU and combiner, and one (1) parabolic antenna. Telecommunications infrastructure is a Use not listed

under the Shire of Waroona Local Planning Scheme No. 7, which means the Council may, at its discretion, permit the use after notice of the application has been given to owners/occupiers of land within the area likely affected by the granting of Planning Consent. Prior to determining the application, Counci is required to seek comments on the proposal. Comments can be submitted in writing, electronically, or by fax.
